# Monuments and plaques

Council approval is required before any monument, headstone or plaque may be installed on the grave site.

The burial rights holder (or a person nominated by the burial rights holder) must make an application to Council and pay the appropriate fee.

If the applicant is someone other than the burial rights holder they need to submit with their application, a statutory declaration form stating the reasons why they have the authority to submit the application to Council.



## Additional interments

In the majority of cases more than one burial can take place in a grave site. Each site needs to be investigated as in some cases the land is not suitable for more than one burial. Ashes can also be placed in most grave sites.

Columbarium walls are only available for single ashes interments. Garden niches allow for two ashes interments.

In all cases, the burial rights holder would need to provide permission.

# **Burial Rights Holder**

The person/s that has been nominated on the burial application form will become the burial rights holder of the plot or niche that has been purchased. Confirmation of the burial rights holder will be sent to you.

The burial rights holder has exclusive right to authorise any burials or ashes placements for that site. The burial right is considered to be part of the holder's personal estate. Should the holder pass away, the holder's executor or heirs and successors would usually administer the estate under these circumstances.



## **Services**

Council offers various services relating to these cemeteries including:

- Searches Assistance with the location and details of family burials
- Plaques

For columbarium walls and garden niches only. A standard plaque is included with the interment fee.





The Maryborough Cemetery is State Heritage listed and on the Local Heritage Register. The Monumental section was established in 1873. The Mortuary Chapel, located in the Monumental Section was erected in 1883 and is a rare example of a late 19th century timber chapel.

The Garden of Rest located on the opposite side of the road from the Monumental Section was opened on 2 March 1960.

It contains the columbarium walls, war graves, garden niche areas and the Children's Memorial Garden.

# **Mementos and flowers**

To ensure that our cemeteries remain a pristine area that honours the memories of those within, Council asks that cemetery patrons comply with the following simple guidelines. Please consider using fresh flowers rather than artificial as they are kinder to our environment.

- Standard plastic vases are available free of charge from dispensing points within the cemetery grounds. Stands are provided for easy access to and display of vases.
- A maximum of 3 standard plastic vases can be placed on each individual gravesite.
- All standard plastic vases and their contents will be inspected each fortnight and old fresh flowers or artificial flowers from each gravesite will be removed.
- The standard plastic vases will be returned to the • dispensing points for reuse.
- Remains of the fresh and old artificial flowers will be placed in refuse bins for disposal.
- Suitable artificial flowers will be placed in designated areas for reuse.
- Trees, shrubs or other plants are not permitted. If planted they will be immediately removed from the lawn or beam sections within the cemeteries.
- Wooden crosses, ornaments, jars, glass or ceramic containers are not permitted within the lawn sections. If used they will be immediately removed from the lawn sections of the cemetery.
- Small ornaments or mementos may be placed within that area relating to the gravesite within the concrete beam sections. No items are to be placed on the grassed area of the gravesite.
- Glass jars, ceramic pots, crosses and large mementos • are not permitted. If used they will be immediately removed from the cemetery.
- Any non-approved items will be removed.
- Mementos and items placed on new graves will not be removed for a period of six (6) months from the date of burial. After this period any non-approved items will be removed. Only standard plastic vases with fresh or artificial flowers will be permitted.
