

## APPLICATION FOR APPROVAL TO KEEP AN ADDITIONAL CAT or DOG

**PURPOSE OF FORM:** This form will be used to process your application for the keeping of an additional cat or dog.

### IMPORTANT INFORMATION

- An approval is required to keep 3 or more cats or dogs over the age of 3 months on any property; or 2 or more cats or dogs over the age of 3 months on any residential unit.
- Desexing of cats and dogs is now compulsory upon registration. For further details and exemptions refer the Desexing of Cats and Dogs Fact Sheet available on Council's website: [www.frasercoast.qld.gov.au](http://www.frasercoast.qld.gov.au).
