

Application for Approval to Keep a Rooster, Pigeons, or Doves

Local Law No. 1 (Administration), Local Law No. 2 (Animal Management) 2011

PURPOSE OF FORM: This form will be used to process your application for the keeping of a rooster, pigeon, or dove.

| IMPORTANT INFORMATION |

| <ul style="list-style-type: none"> Only one person can be the registered owner/keeper of the animal/s. The owner must also be 18 years or over. An approval is required to keep a rooster, pigeons, or doves in an urban area, or on a property less than 10,000 square metres. Enclosures are to be thoroughly cleaned once per week, must not be sited closer than 2 metres from the property boundaries, located at the rear of the premises behind the residence (if any) situated on the premises, and be 10 metres away from any local government or State-controlled Road. Written consent must be obtained from any occupiers of adjoining properties; and If the applicant is not the owner of the land on which the animal is to be kept - written consent must be obtained from the owner of the land. <p>Additional Criterion for keeping of a rooster:</p> <ul style="list-style-type: none"> The applicant must produce evidence of current membership of a recognised and functioning poultry club; and The applicant must demonstrate suitable measures to mitigate noise emitted by the rooster. |
