## Guidelines for community organisations – councillor discretionary funds

Introduction	The Fraser Coast Regional Council Councillor discretionary fund actively supports community purpose initiatives that provide services to the Fraser Coast region.
Expense Guidelines	Expense must be for a community purpose that encourages sporting, recreational and social pursuits; fosters the regions heritage and cultural diversity; promotes environmental protection and sustainability; supports and builds relationships with disadvantaged or vulnerable groups; provides economic benefits to the region; encourages educational opportunities and initiatives and contributes to community wellbeing.
Who can apply?	<p>Applicants must be a non-profit community based organisation who meets the eligibility criteria in Council’s Councillor Discretionary Funds policy.</p> <p>Applications must be made on the Councillor discretionary fund application form and may be forwarded any time during the financial year.</p>
Eligibility - Expenditure	<ul style="list-style-type: none"> <li>• Expenditure must be for a Community Purpose</li> <li>• Requests are from non-profit community based organisations or groups</li> </ul> <p><u>Eligible expenditure includes items that:</u></p> <ul style="list-style-type: none"> <li>• Improve access to and the quality of community facilities;</li> <li>• Support community arts and culture activities;</li> <li>• Respond to the needs of particular groups in the community e.g. young people, seniors etc.</li> <li>• Respond to special needs in the community e.g. homelessness, disadvantage;</li> <li>• Improve the environment and amenity of the region;</li> <li>• Contribute to community safety;</li> <li>• Contribute to improved health and well-being;</li> <li>• Purchase small equipment to resource community organisations;</li> <li>• Create opportunities for residents to be informed and involved in the community;</li> </ul> <p><u>Ineligible expenditure includes:</u></p> <ul style="list-style-type: none"> <li>• Expenditure that is not consistent with the Councillor Discretionary Funds policy;</li> <li>• Requests primarily for personal gain or advancement;</li> <li>• Events, functions or activities run for a commercial purposes;</li> <li>• Events, functions or activities that take place outside the Fraser Coast Regional Council region;</li> <li>• Funding of ongoing organisation operational or recurrent costs e.g. insurance, electricity, rates, telephones, security, administration costs, rent etc.</li> <li>• Purchase of Raffle tickets.</li> <li>• Sponsorship and/or donations to eligible not for profit entity.</li> </ul>
