

Fraser Coast Wetlands Photography Competition

Terms and Conditions

These terms and conditions apply to Fraser Coast Regional Council's Wetlands Photography Competition run from 2 February – 28 February, 2021. By entering, entrants accept these terms.

1. Entry is open only to Fraser Coast residents, in the following age groups; Under 12 years; 12-17 years and over 18 years.
2. Council employees, their immediate families, and employees of companies associated with this competition are ineligible to enter.
3. The competition will be conducted during the competition period (Tuesday 2 February – Sunday 28 February, 2021).
4. To enter the competition, entrants must email a photograph inspired by the theme: 'Wetlands, Water and Life' to Environment@frasercoast.qld.gov.au or share it to Council's Facebook page with their name, age and location of the photograph included.
5. Council accepts no responsibility for late entries.
6. To receive the prize the winner is required to provide Fraser Coast Regional Council their personal details and if under 18 years must have a legal guardian's permission to provide the requisite details.
7. The competition will be judged on Monday 1 March, 2021.
8. There will be one winner's prize per age group. The prize is a Whale Watching double pass.
9. This prize must be taken as stated and no compensation will be payable if the winner is unable to use it in this way. Any additional costs incurred by the winner, other than those which form part of the prize, are the responsibility of the winner. The prizes are not transferable for any other Council services, fees, charges or cash.
10. Entrants are required to participate in all promotional activity surrounding this competition or the winning of any prize, free of charge, and they consent to Council using their name and image in promotional material.
11. Council will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence) in connection with this competition or accepting or using any prize, except for any liability which cannot be excluded by law.
12. Council may in its discretion suspend, cancel or recommence the competition if for any reason the competition is not capable of running as planned, or the determination of the prize winner or the delivery of the prize is prevented or hindered by any outside agent or event.
13. Council will use any personal information provided for the purpose of entering the competition and notifying a winner. Council is authorised to collect this information in accordance with the *Local Government Act 2009* and other local government acts. By submitting an entry, you consent to Council publishing your name and image in our publications or other local media.
