This product is made from organic materials, including composted pinebark and contains living microorganisms, including bacteria, fungi, protozoa, proteases (CAS No.: 9068-59-1) and may contain organofluorine compounds.

This product contains less than <0.1% respirable crystalline silica. Moisture content of 25-35%.

#### 4. FIRST-AID MEASURES

### **Inhalation**

## 7. HANDLING AND STORAGE

#### **Precautions for Safe Handling**

Read detailed warning label on this product.

Avoid inhalation of dust/mist, and skin or eye contact. It is bioaerosols. Use only in a well ventilated area. Keep product moist when handling to avoid dust. Wear particulate mask if dusty. Keep containers sealed when not in use. Prevent the generation and build up of dust in the work atmosphere. Establish good housekeeping practices. Remove dust accumulations on a regular basis by vacuuming or gentle sweeping to avoid creating dust clouds. Maintain high standards of personal hygiene i.e. washing hands prior to eating, drinking, smoking or using toilet facilities.

## Conditions for safe storage, including any incompatibilities

Store this product in a cool location. Store in a well ventilated area away from heat and sources of ignition, out of direct sunlight and moisture. Take precautions against static electricity discharges. Use proper grounding procedures. Store away from incompatible materials such as materials that support combustion (oxidising materials). Store in suitable, labelled containers. Inspect periodically for deficiencies such as damage or leaks. Have appropriate fire extinguishers available in and near the storage area. Ensure that storage conditions comply with applicable local and national regulations.

Repeated exposure to respirable crystalline silica dust may lead to silicosis, or other serious delayed lung injury. The onset of silicosis is usually slow and lung damage may occur even when no symptoms or signs of ill-health have occurred. Silicosis can develop to a more serious degree even after exposure has ceased, and may also lead to other diseases including heart disease and scleroderma. Exposure by inhalation may aggravate pre-existing upper respiratory and lung disorders such as bronchitis, emphysaema and asthma. Dust generation should be avoided.
