Given that Denis's motion (either version) runs counter to the advice of Hendrik of TMR, as conveyed to us at the recent briefing, is it possible to have the following information available for Wednesday?

1. Can we have a summary of the parts of that briefing that need to remain confidential, if any? I recall that there was some mention of confidentiality, but I can't recall what exactly that related to. Perhaps it included the budgetary position of the project, and the implications for any extensions to the project scope?

I am not fully aware of the confidential aspects of the briefing provided and the Tiaro Bypass project so not in a position to make any comments on this matter.

Given the political sensitivity, my suggestion is we should put the motion to Hendrik to see if there are any major concerns around the intent of the motion and if there are any amendments required to better align with any political issues. I understand Cr Chapman has attended a field day on Tiaro Bypass over the weekend with Hendrik and I am not sure if Cr Chapman had further discussions around the intent of the motion.

As suggested above, probably worth seeking Hendrik's feedback on the proposed motion.

- 3. Can we get relevant traffic count data? I note in this context Hendrik's comments about demand, and about delays likely to be experienced in the future entering the highway from Bauple Drive. I am also interested in a count of how many traffic movements there are per day of traffic coming from Bauple and heading further north than Tiaro, and vice versa.
 - DTMR counts for Tahiti Road for 2018 111 veh/day
 - FCRC counts for Bauple Drive Nort for 2022 634 veh/day

Traffic count data collected by Council and other agencies are a specific location count only and there is no provision to record individual vehicles for destination counts. The counting system cannot determine how many vehicles would be travelling just to Tiaro versus those that would be travelling further north however, DMTR may have undertaken some forecast modelling to predict the percentage of traffic traveling further north of Tiaro as part of their assessment in developing the business case.

4. I note Denis, Hendrik and Davendra had a later site meeting. Is it possible for Hendrik and Davendra to advise whether, from their points of view, any new information or possible variations arose from these discussions? (I don't need any advice if it simply went over the ground covered in the briefing.)

I can advised that at the catch up meeting last week, DTMR confirmed that they are not deviating from their current layout of Tiaro Bypass and that the interchange at Tahiti Road will progress as per their layout plan published on their website. They have also confirmed that the design will make provision for a full diamond at Tahiti Road for a future on/off ramp facility. Cr Chapman and Cr Truscott has offered to discuss with Llew O'Brien and Tony Perrett to advocate to the Minister for Main Roads to go to tender to test the market on the cost for the full diamond and subject to the final tender price and available budget, DTMR may give further consideration for the diamond proposal. Hendrik seemed comfortable with this approach.





1. Can we have a summary of the parts of that briefing that need to remain confidential, if any? I recall that there was some mention of confidentiality, but I can't recall what exactly that related to. Perhaps it included the budgetary position of the project, and the implications for any extensions to the project scope?

I am not fully aware of the confidential aspects of the briefing provided and the Tiaro Bypass project so not in a position to make any comments on this matter.

Given the political sensitivity, my suggestion is we should put the motion to Hendrik to see if there are any major concerns around the intent of the motion and if there are any amendments required to better align with any political issues. I understand Cr Chapman has attended a field day on Tiaro Bypass over the weekend with Hendrik and I am not sure if Cr Chapman had further discussions around the intent of the motion.

2. Is it possible to get a written summary of TMR's position on the matters raised by the motion, for tabling? (Presumably containing the substance of the advice at that briefing.)

As suggested above, probably worth seeking Hendrik's feedback on the proposed motion.

- 3. Can we get relevant traffic count data? I note in this context Hendrik's comments about demand, and about delays likely to be experienced in the future entering the highway from Bauple Drive. I am also interested in a count of how many traffic movements there are per day of traffic coming from Bauple and heading further north than Tiaro, and vice versa.
 - DTMR counts for Tahiti Road for 2018 111 veh/day

FCRC counts for Bauple Drive Nort for 2022 - 634 veh/day

Traffic count data collected by Council and other agencies are a specific location count only and there is no provision to record individual vehicles for destination counts. The counting system cannot determine how many vehicles would be travelling just to Tiaro versus those that would be travelling further north however, DMTR may have undertaken some forecast modelling to predict the percentage of traffic traveling further north of Tiaro as part of their assessment in developing the business case.

4. I note Denis, Hendrik and Davendra had a later site meeting. Is it possible for Hendrik and Davendra to advise whether, from their points of view, any new information or possible variations arose from these discussions? (I don't need any advice if it simply went over the ground covered in the briefing.)

I can advised that at the catch up meeting last week, DTMR confirmed that they are not deviating from their current layout of Tiaro Bypass and that the interchange at Tahiti Road will progress as per their layout plan published on their website. They have also confirmed that the design will make provision for a full diamond at Tahiti Road for a future on/off ramp facility. Cr Chapman and Cr Truscott has offered to discuss with Llew O'Brien and Tony Perrett to advocate to the Minister for Main Roads to go to tender to test the market on the cost for the full diamond and subject to the final tender price and available budget, DTMR may give further consideration for the diamond proposal. Hendrik seemed comfortable with this approach.

- 3. Can we get relevant traffic count data? I note in this context Hendrik's comments about demand, and about delays likely to be experienced in the future entering the highway from Bauple Drive. I am also interested in a count of how many traffic movements there are per day of traffic coming from Bauple and heading further north than Tiaro, and vice versa.
 - DTMR counts for Tahiti Road for 2018 111 veh/day
 - FCRC counts for Bauple Drive Nort for 2022 634 veh/day

Traffic count data collected by Council and other agencies are a specific location count only and there is no provision to record individual vehicles for destination counts. The counting system cannot determine how many vehicles would be travelling just to Tiaro versus those that would be travelling further north however, DMTR may have undertaken some forecast modelling to predict the percentage of traffic traveling further north of Tiaro as part of their assessment in developing the business case.

4. I note Denis, Hendrik and Davendra had a later site meeting. Is it possible for Hendrik and Davendra to advise whether, from their points of view, any new information or possible variations arose from these discussions? (I don't need any advice if it simply went over the ground covered in the briefing.)

I can advised that at the catch up meeting last week, DTMR confirmed that they are not deviating from their current layout of Tiaro Bypass and that the interchange at Tahiti Road will progress as per their layout plan published on their website. They have also confirmed that the design will make provision for a full diamond at Tahiti Road for a future on/off ramp facility. Cr Chapman and Cr Truscott has offered to discuss with Llew O'Brien and Tony Perrett to advocate to the Minister for Main Roads to go to tender to test the market on the cost for the full diamond and subject to the final tender price and available budget, DTMR may give further consideration for the diamond proposal. Hendrik seemed comfortable with this approach.
