The Executive Manager Process Operations expressed his thanks to the Executive Leadership Team following their endorsement of annual Live Sewer Allowance as a disability allowance being implemented for all Sewerage Treatment Plant Operators. This is a fantastic result for the team and will bring the Operators wage in line with six other Local Governments in Queensland.

The Executive Manager Network Operations and Maintenance was pleased to see the efficiency of both the water and sewer crews who were undertaking work within the same street, implemented joint traffic controls for both crews to undertake their jobs safely. This is a great demonstration of teams using their initiative and working together to create efficiency within the work place.

The Director Water and Waste Services recognised the initiative of the Laboratory team who visited the Gold Coast water laboratory yesterday to finalise the test method that will allow Council to provide legionella testing at our WaterOne laboratory. The initiative will allow the lab to offer and important and in demand testing service to local and regional Hospital and health service providers.

The Committee congratulated the Executive Manager Engineering and Technical Services and the Planning and Environmental Services Manager following the milestone decision by Council this week to adopt the business case for the Water Grid.

WBWWS 5.2 Burrum River Weir 1 Speed Limit Reduction

RESOLUTION (Michelle Byrne/Janice Wilson)

That the Water and Waste Advisory Committee:

- Receive the Council report seeking Council endorsement delegating authority to the Chief Executive Officer to provide a formal submission to Maritime Safety Queensland requesting the speed limit on Burrum River Weir No. 1 be reduced to 6 knots to address the current safety and environmental risks, noting that:
 - a) Community engagement returned a 92% positive response to reducing the speed limit on Burrum Weir No. 1 to 6 knots.
 - b) Council has no regulatory role in enforcing speed limits on the Burrum River.
 - c) A speed limit of 6 knots would be consistent with the limits imposed by Council on Lake Lenthall.
- 2. Endorse the proposal to request a reduction of boating speed limits on Burrum Weir 1.
