The Executive Manager Resource Recovery Services thanked Cr O'Keefe, who has been appointed as the Chair, for chairing the meeting and hosting the meeting on the Fraser Coast.

The Executive Manager Resource Recovery Services praised the assistance and time taken by the new Safety Business Partner, following his visit to the Maryborough Landfill this week, for identifying a number of improvements that can be undertaken to improve safety at the site. The Executive Manager Resource Recovery said he is looking forward to working with the new safety team to achieve positive outcomes.

Committee Member Wilson and the Business Services Manager expressed their thanks and appreciation following the meeting with Council's Internal Auditor. The meeting was a great opportunity to discuss audit processes and procedures and exchange of ideas and ways to continuously improve in the quality management space.

The Business Services Manager commended the Resource Recovery Team for the recent opening of the Waste to Art exhibition. The event was well received and saw over 130 entries this year.

Yesterday a Process Operations team member suffered a medical treatment injury while working at a sewerage treatment plant. The incident is currently being investigated.

The Executive Manager Network Operations and Maintenance thanked and commended the teamwork and initiative demonstrated by the Lead Engineer who arranged a contractor to conduct repairs and relining of a sewer manhole that was recently damaged by an excavator. Her efforts were greatly appreciated.
