IMPORTANT NOTES

1. The supply of incomplete information will result in delays in the processing of your application.
2. Trade waste charges: There is a charge for the discharge of trade waste to Wide Bay Water's sewerage system based on the quantity and quality of the discharged. These charges are set by Wide Bay Water and will increase by at least CPI each financial year. Refer to www.frasercoast.qld.gov.au for the current schedule of fees and charges.
3. Additional information is available from Wide Bay Water (ph. 1300 79 49 29 or www.frasercoast.qld.gov.au)
4. A plumbing and drainage clearance certificate must be issued before a Trade Waste Approval is issued.
5. Under Queensland's Waste Management Legislation (s35 (3) of the Environmental Protection (Waste Management) Regulation 2000 waste handlers are required to submit waste tracking information to the Department of Environment and Heritage Protection. Wide Bay Water has an approved waste tracking system and to improve efficiencies, will report on your behalf.
6. Pre-treatment servicing contractors must be approved by Wide Bay Water and where necessary, use Wide Bay Water's approved waste tracking system.
