The Australian Government of Human Services (the Department) to provide the results of that enquiry to Fraser Coast Regional Council.

I understand that the Department will disclose personal information to Fraser Coast Regional Council including my name, address, payment type, payment status and concession card type and status to confirm my eligibility for relevant concession.

This consent, once signed, remains valid while I am a customer of Fraser Coast Regional Council unless I withdraw it by contacting the Fraser Coast Regional Council or the Department. I can get proof of my circumstances/details from the Department and provide it to Fraser Coast Regional Council so my eligibility for relevant concession can be determined. If I withdraw my consent or do not alternatively provide proof of my circumstances/details, I may not be eligible for the concession provided by Fraser Coast Regional Council.

IMPORTANT INFORMATION

1. Application must be made in writing on the abovementioned form.
2. To be eligible for concession, the registered owner of the animal/s must be the holder of:
 - Queensland 'Pensioner Concession Card' issued by Centrelink
 - Queensland 'Repatriation Health Card - For All Conditions' (Gold card)
 - Veterans' Affairs Service Card (Gold card)

Please note that a Health Care Card, Queensland Seniors Card or Seniors Business Discount Card does not entitle the holder to receive a concession.
3. The address recorded with Centrelink **must verify** as the address for which the concession is being claimed.
 - a. Upon proof of eligibility the entitlement to the concession, there will be no backdating to previous animal registration periods, regardless of previous eligibility.
