

## New Animal Registration Form / Change of Ownership Form

*Local Law No. 2 (Animal Management) 2011 and Animal Management (Cats and Dogs) Act 2008*

### IMPORTANT INFORMATION

- It is mandatory for dogs 12 weeks and over to be registered.
- No more than two (2) dogs are allowed to be kept on any property, unless a permit to do so has been approved.
- No more than one (1) dog is allowed to be kept in a residential unit (residential development comprising multiple units on a single lot; multiple dwellings; duplex, accommodation units, caravan park or retirement village); unless a permit to do so has been approved.
- Animal registration renewal fees apply – refer to the Fees & Charges schedule.
- Dog/s must comply with Council's requirements for desexing (animal/s must be desexed within 28 days of registration).
- Being a member of a breeder association is not an exemption for desexing. An application for annual breeder approval must be sought.

*Note: animals registered for the first time only, in the Fraser Coast Region, will be registered free of charge for the current registration period only.*

### PROHIBITED ANIMALS *\*the following dogs (including cross-breeds) are prohibited within the Fraser Coast boundaries.*
